Miss Fudge tailed the field throughout.</p> <p>Miss Fudge was vetted following the event. It was reported that there was no apparent injury found. Stewards spoke to trainer Mr. T Boehmke regarding the performance of Miss Fudge in this event. Mr Boehmke explained that the greyhound had ran well in a recent trial at Bendigo and was expecting a better showing today. Mr Boehmke further added that he will be sending the greyhound for some re-education and also give the greyhound a brief let up from racing before trying again as the greyhound has only had two race starts. Acting under GAR 69(1) Stewards charged It Is Done with marring. Mr Buchanan pleaded guilty to the charge, It Is Done was found guilty and suspended for 28 days at Bendigo and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.</p> |

Ryben Jack and Are You Ready collided soon after the start. Alpanda and One Smarty collided soon after the start, checking One Smarty. Ryben Jack galloped on Alpanda soon after the start, checking both greyhounds. Sugar Mountain, Mahjong Heat and Alpanda collided approaching the first turn, checking all three greyhounds. One Smarty checked off Sukoku Buddah approaching the first turn. Are You Ready checked off Sudoku Buddah on the first turn. Sugar Mountain crossed wide on the first turn, checking One Smarty and Sugar Mountain. Ryben Jack, Are You Ready and Mahjong Heat collided approaching the home turn, checking all three greyhounds. Sugar Mountain raced wide on the home turn. Mahjong Heat and Are You Ready collided entering the home straight, checking Are You Ready. Sugar Mountain and One Smarty raced wide in the home straight.</p>  |
| <p><b>Race 10</b></p> <p>GOLDEN CITY CONCRETE PUMPING<br/>(300+RANK)<br/>5:14 pm<br/>425m<br/>Grade 7</p> | <p>A pre-race sample was taken from Idaho Blue.</p> <p>Tiger Tees was quick to begin. Communique and Seeka Moment collided soon after the start. Our China Plate, Siamese Dream and Tiger Tees collided approaching the first turn, checking Tiger Tees. Seeka Moment, Communique and Lancome Lady collided on the first turn, checking Lancome Lady. Idaho Blue checked off Seeka Moment approaching the home turn, checking Shimmy Dat Ray and Communique. Seeka Moment and Siamese Dream collided approaching the winning post.</p> <p>Tiger Tees was vetted following the event. It was reported that there was no apparent injury found. Stewards spoke to Trainer Tony Duncan regarding the race manner of Tiger Tees in the back straight. Mr Duncan explained that the greyhound can be hesitant around other dogs. Stewards established that Tiger Tees began well and clearly led the field in the back straight before Siamese Dream approached on the outside, soon after Siamese Dream crosses to the rail and checks Tiger Tees. Without supporting evidence of back straight head on vision Stewards could not be comfortably satisfied to the required standard that Tiger Tees had eased of its own accord and that Siamese Dream was not bumping with Tiger Tees prior to crossing to the rail and checking Tiger Tees. As such no action was taken against Tiger Tees.</p> |
| <p><b>Race 11</b></p> <p>HIT 91.9 BENDIGO (300+RANK)<br/>5:38 pm<br/>425m<br/>Grade 6</p>                 | <p>A pre-race sample was taken from Monoak.</p> <p>Beast and Gin Lee's Pride were slow to begin. Kowari crossed to the rail on the first turn, checking Vintage Queen and Beast. Monoak and Paid Too Much collided on the first turn, checking Paid Too Much.</p>   |
| <p><b>Race 12</b></p> <p>TOP CAT VIDEO (300+RANK)<br/>6:02 pm<br/>425m<br/>Grade 5</p>                    | <p>Mr Alex Whitehead, trainer of Sudoku Baby, declared a new weight of 24.5 kgs for the greyhound in accordance with GAR 39(2). Sudoku Baby last raced at 26.0 kgs.</p> <p>A pre-race sample was taken from Bald Wal.</p> <p>Bald Wal, Toss and Sudoku Baby collided soon after the start. Toss and Sublime Sull collided approaching the first turn, checking both greyhounds. Seabrook Dill and Gone Rusty collided on the first turn, checking Gone Rusty. Bald Wal checked off Gone Rusty approaching the home turn. Bald Wal and Toss collided on the home turn. Angel Of Glory and Sublime Sull collided several times on the home turn and in the home straight. Angel Of Glory and Toss collided approaching the winning post.</p>  |

Angel Of Glory was vetted following the event. It was reported that the greyhound sustained an abrasion on the left stopper and a pelvic injury to the left side, a seven day stand down period was imposed. Stewards spoke to trainer Ronald Fisher regarding the racing manners of Angel Of Glory approaching and rounding the home turn. Mr Fisher stated that Angel Of Glory is a greyhound that likes to follow the lure and in his opinion had followed the lure again tonight out to the middle of the track and that Veetee Mist had shifted in slightly making the two greyhounds collide on several occasions. Mr Fisher added that in the home straight the greyhound crossed back to the middle of the track into the direct line of the lure. Stewards noted the explanation of Mr Fisher, the injuries sustained and took no action against the greyhound.

Supplementary Report:

Satisfactory Trial Results - Mahjong Magic trialled over the 425m from box one, weight 34.2 kgs, the greyhound was placed first in a field of four. The time of the trial was 24:15, the greyhound won by a margin of one lengths. Mahjong Magic was Not Cleared, as the greyhound turned it's head outwards at the start.

Satisfactory Trial Results - Night Theory trialled over the 425m from box two, weight 32.1 kgs, the greyhound was placed second in a field of four. The time of the trial was 24:15, the greyhound was beaten by a margin of one length. Night Theory was Cleared.

Satisfactory Trial Results - Saloon Princess trialled over the 425m from box four, weight 28.3 kgs, the greyhound was placed fourth in a field of four. The time of the trial was 24:15, the greyhound was beaten by a margin of eight lengths. Saloon Princess was Cleared. A pre trial sample was taken from Saloon Princess.

Satisfactory Trial Results - Mister Peanuts trialled over the 425m from box eight, weight 30.2 kgs, the greyhound was placed third in a field of four. The time of the trial was 24:15, the greyhound was beaten by a margin of 7.25 lengths. Mister Peanuts was Not Cleared, as the greyhound turned it's head inwards in the home straight hampering Saloon Princess.

Stewards today concluded an inquiry regarding the incorrect greyhound being removed from the trial kennels at Bendigo on 28 March 2018 and being trialled. After taking evidence from handlers Mr K Blake and Ms J Warzwoda and licensed trainers Mrs S Gray and Mr C Blake, Stewards established that there had been a misunderstanding between Mr K Blake and Mr C Blake. As Stewards could not be comfortably satisfied that any one party was totally responsible for the incident occurring no action was taken, other than to strongly advise Mr K Blake to review his procedures when retrieving greyhounds from the kennels. Mr K Blake stated that since the incident on 28 March 2018 he had indeed changed his procedures and been extra vigilant when performing his duties as a kennel attendant.
