Elram Girl was vetted following the event. It was reported that the greyhound sustained a left triangle muscle injury, a 28 day stand down period was imposed. Mr Jack, ther trainer of Elram girl was advised that he must seek follow up veterinary care for the greyhound within three days.

Stewards spoke to Mr Shane Jack, the trainer of Elram Girl regarding the greyhound's racing manners on the first turn. Mr Jack started that in his opinion the greyhound often has trouble navigating the first turn at this track. Stewards consulted with the on-course veterinarian who stated that Elram Girl was found to have swelling and pain to the left triangle muscle and will require strict rest and further veterinary treatment in the coming days. Stewards took into consideration the veterinary report and could not be comfortably satisfied that a failing to chase charge was appropriate on this occassion.
