Sea Mist last raced on 9 November 2017. Mr McCullagh stated that the greyhound was returning to racing following an extended spell. Pursuant to GAR 77A, Sea Mist trialed over the 410m from box three, weight 29.8 kgs, the greyhound was placed first in a field of four. The time of the trial was 23:83, the greyhound won by a margin of 9.75 lengths. Sea Mist was Cleared.</p>
