Re-Vetted Greyhound

311m Grade Elram Girl was presented for a re-vet at the conclusion of kennelling and was cleared to race.

Satisfactory Trials

Stewards spoke to Mr.l. Newcome, the trainer of Zara's Pride regarding the length of time since the greyhound last raced. Zara's Pride last raced on 11th November 2017. Mr. Newcombe stated that the greyhound was returning to racing after a seasonal break. Pursuant to GAR 77A, Zara's Pride trialled over the 311 metre distance from box 1, weight 29.6kgs. The greyhound was placed 3rd, in a field of 4. The time of the trial was 17.92. The greyhound was beaten by a margin of 3.75 lengths. Zara's Pride. was cleared.

Stewards spoke to Mr. J. Talgi, the trainer of Flying Hareeba regarding the length of time since the greyhound last raced. Flying Hareeba last raced on 15th May 2017. Mr. Talgi stated that the greyhound was returning to racing after injuries to its stopper bone and toe. Pursuant to GAR 77A, Flying Hareeba trialled over the 311 metre distance from box 4, weight 26.7kgs. The greyhound was placed 2nd, in a field of 4. The time of the trial was 17.92. The greyhound was beaten by a margin of 3 lengths. Flying Hareeba was cleared.
