It was reported that the greyhound sustained injuries to a left foreleg wrist, a 10 day stand down period was imposed. Acting under GAR 69(B)(1), the Stewards charged Dyna Vagrant with failing to pursue the lure with due commitment (by reason of injury). Mr Grenfell pleaded not guilty to the charge, Dyna Vagrant was found guilty and Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
