Satisfactory Trial Results - Happy Allen trialled over the 400mtrs from box 2, weight 25.5kgs, the greyhound was placed 3rd in a field of 4. The time of the trial was 23.32, the greyhound was beaten by a margin of 4 lengths. Happy Allen was Not Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs Margaret Campbell, the trainer of Gypsy Marlow regarding the length of time since the greyhound last raced. Gypsy Marlow last raced on 20 November 2017 and is returning from a left front sesamoid and metatarsal injuries. Pursuant to GAR 77A, Gypsy Marlow trialled over the 400mtrs from box 3, weight 25.3kgs, the greyhound was placed 4th in a field of 4. The time of the trial was 23.32, the greyhound was beaten by a margin of 6 1/4 lengths. Gypsy Marlow was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Gary Sciortino, the trainer of Miss Hot Rocks regarding the length of time since the greyhound last raced. Miss Hot Rocks last raced on 29 November 2017 and is returning from seasonal.
