Stewards spoke to Ms. R. Groom and Mr. S. Waycott regarding an incident that occured on Monday the 11th of June 2018 at the Shepparton Greyhound Racing Club.

Stewards issued a warning to Mr. Waycott in regards to following club staff directions.

Satisfactory Trial Results 390m -

Outlaw Arnhem trialled over the 390m from box 3, weight 34.5kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 22.76, the greyhound won by a margin of 1.5L. Outlaw Arnhem was cleared

Stewards spoke to Mr Jason Whybrow, the trainer of Northen Bowler regarding the length of time since the greyhound last raced. Northen Bowler last raced on 15 September, 2017. Mr Whybrow stated that the greyhound has had a change of kennels. Pursuant to GAR 77A, Northen Bowler trialled over the 390m from box 1, weight 26.0Kgs, the greyhound was placed 4 in a field of 4. The time of the trial was 22.76, the greyhound was beaten by a margin of 3.75L. Northern Bowler was cleared
