Acting under GAR 69(1) stewards charged Crash Cobra with marring. Mr Giddings pleaded guilty to the charge, Crash Cobra was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
