Race 1

Acting under GAR 69(A)(1) Stewards charged Placid Pause with failing to pursue the lure with due commitment. Mr Bain pleaded not guilty to the charge, Placid Pause was found guilty and suspended for 28 days at Sandown and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Miss Tatts was vetted following the event. It was reported that the greyhound sustained left hindleg split webbing and pencil/whip injuries, a 14 day stand down period was imposed.

Stewards spoke to Ms Jeanette Imlach, the trainer of the greyhound Kimani, regarding the greyhounds racing manners on the second turn. Kimani was vetted and re-vetted following event six. It was reported that the greyhound sustained injuries to the right foreleg deltoid and trapezius muscles, a seven day stand down period was imposed. Acting under GAR 69(B)(1), the Stewards charged Kimani with failing to pursue the lure with due commitment (by reason of injury). Ms Imlach pleaded guilty to the charge, Kimani was found guilty and Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Mrs Schmidt pleaded guilty to the charge, Major Think was found guilty and suspended the greyhound for 12 months (all tracks) and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(c), before any future nomination will be accepted.

Cass' Cass was vetted following the event. It was reported that the greyhound sustained a left foreleg wrist injury, a 21 day stand down period was imposed.

Crackerjack Blax was vetted following the event. It was reported that the greyhound sustained a right hindleg hock injury, a 90 day stand down period was imposed.
