Acting under GAR 69 (A)(1) Stewards charged Hello Nimble with failing to pursue the lure with due commitment. Mr. Romagnino pleaded guilty to the charge, Hello Nimble was found guilty and suspended for 28 days at Traralgon and it was directed that the greyhound perform a satisfactory trial all tracks pursuant to GR 69(A)(2)(a) before any future nomination will be accepted.

Re-vet:-

She's Our Poppy was presented for a re-vet at the conclusion of kennelling and was not cleared to race.

Satisfactory Trial Results (GAR 77A):-

Stewards spoke to Mr. William McMahon, the representative of Dr. Yanma regarding the length of time since the greyhound last raced. Dr. Yanma last raced on 16 November 2017 and is returning to racing following an injury to both hocks. Pursuant to GAR 77A, Dr. Yanma trialled over the 315m from box 8, weight 35.5kg, the greyhound was placed fourth in a field of 4. The time of the trial was 17.88 secs, the greyhound was beaten by a margin of 7 lengths. Dr. Yanma was Cleared.
