Satisfactory Trial Results (GAR 77A) - Stewards spoke to Ms Mandy Shaw, the representative of Fantastic Bear regarding the length of time since the greyhound last raced. Fantastic Bear last raced on 5 October 2017 and is returning from an extended spell. Pursuant to GAR 77A, Fantastic Bear trialled over the 400mtrs from box 1, weight 34.5kgs, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.77, the greyhound was beaten by a margin of 7 ¼ lengths. Fantastic Bear was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Tom Noy, the trainer of Acola Rosebud regarding the length of time since the greyhound last raced. Acola Rosebud last raced on 2 July 2017 and is returning from a seasonal break. Pursuant to GAR 77A, Acola rosebud trialled over the 400mtrs from box 5, weight 25.9kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 22.77, the greyhound was beaten by a margin of 5 lengths. Acola Rosebud was Cleared.

Satisfactory Trial Results - Dyna Nancy trialled over the 400mtrs from box 8, weight 27.6kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 22.77, the greyhound won by a margin of 5 lengths. Dyna Nancy was Cleared.
