News Print was vetted following the event. It was reported that the greyhound sustained no apparent injury.

But What For was vetted following the event. It was reported that the greyhound sustained an injury to the right long head triceps (monkey) muscle. A 21-day stand down period was imposed.

Stewards spoke to Mr Adam Wilcock, the trainer of the greyhound Senor Ollie, regarding the greyhound's racing manners at the 200m mark. Senor Ollie was vetted and or re-vetted following event seven. It was reported that the greyhound sustained injuries to the right shoulder and general cervico-thoracic area, a

14-day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Senor Ollie with failing to pursue the lure with due commitment (by reason of injury). Mr Wilcock pleaded guilty to the charge, Senor Ollie was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
