It was reported that the greyhound sustained a right hind triangle muscle injury, a 14 day stand down period was imposed. Acting under GAR 69(B)(1), the stewards charged Gypsy Rules with failing to pursue the lure with due commitment (by reason of injury). Ms. Houlahan pleaded guilty to the charge, Gypsy Rules was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.
