Satisfactory Trial Results & Weight Trial (GAR 77A) - Stewards spoke to Mr Troy Scott, the trainer of Are You Serial regarding the length of time since the greyhound last raced. Are You Serial last raced on 29 July 2017 and is returning from a change of kennels. Pursuant to GAR 77A, Are You Serial trialled over the 400mtrs from box 1, weight 26.2kgs, the greyhound was placed 4th in a field of 4. The time of the trial was 22.92, the greyhound was beaten by a margin of 12 1/2 lengths. Are You Serial was Cleared.

Satisfactory Trial Results & Weight Trial (GAR 77A) - Stewards spoke to Mr Jake Collins, the representative of Zipping Tex regarding the length of time since the greyhound last raced. Zipping Tex last raced on 5 August 2017 and is returning from a change kennels. Pursuant to GAR 77A, Zipping Tex trialled over the 400mts from box 8, weight 36.0kgs, the greyhound was placed 1st in a field of 4.
