Satisfactory trial results (GAR 77A):-

Mr. Haas stated that the greyhound was returning to racing following an injury to both back muscles. Pursuant to GAR 77A Burnt Orange trialed over 400 metres from box 8, weight 31.9kg, the greyhound was placed first in a field of 4. The time of the trial was 23.32 secs, the greyhound won by a margin of 2 lengths. Burnt Orange was cleared.
