Satisfactory trial results:-

Wicked Hillary trialed over 400 metres from box 8, weight 27.7kg, the greyhound was placed first in a field of 4. The time of the trial was 23.42 secs, the greyhound won by a margin of .75 lengths. Wicked Hillary was cleared.

Tory's Rocket trialed over 400 metres from box 1, weight 25.4kg, the greyhound was placed fourth in a field of 4. The time of the trial was 23.42 secs, the greyhound was beaten by a margin of 11.75 lengths (turned in the boxes and was very slow to begin 7.5 lengths). Tory's Rocket was not cleared.
