Satisfactory Trial Results - Miss Winks trialled over the 400m from box one, weight 26.2kg, the greyhound was placed third in a field of six. The time of the trial was 23.89, the greyhound was beaten by a margin of 2.75L. Miss Winks was not cleared.

Satisfactory Trial Results - Krazy Blaze trialled over the 400m from box three, weight 28.0kg, the greyhound was placed fifth in a field of six. The time of the trial was 23.89, the greyhound was beaten by a margin of 4.25L. Krazy Blaze was cleared.

Satisfactory Trial Results - Krazy Jane trialled over the 400m from box five, weight 26.0kg, the greyhound was placed first in a field of six. The time of the trial was 23.89, the greyhound won by a margin of 2.25L. Krazy Jane was cleared.
