Telling regarding his difficulty in boxing the greyhound Heza Gem, Mr. Telling stated that the greyhound kicked back while he was trying to place it in the boxes and then felt that after the starter and others attempted to assist, it made it slightly more difficult for him. Stewards noted his explanation and directed that Heza Gem be boxed first in future events. Stewards will advise the starter that he is the only person to render assistance with difficult to box greyhounds in accordance with GAR 51(6).
