Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mrs P. Andrews, the trainer of Power Burst regarding the length of time since the greyhound last raced. Power Burst last raced on 6 August 2017. Mrs Andrews stated that the greyhound was returning from a spell. Pursuant to GAR 77A, Power Burst trialed over 395mtrs from box 1, weight 36.2kgs, the greyhound was placed 4th in a field of 4. The time of the trial was 22.76, the greyhound was beaten by a margin of 9.25 lengths. Power Burst was Cleared.

Satisfactory Trial Results - Our Charlie Rose trialed over the 395mtrs from box 8, weight 32.6kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 22.76, the greyhound won by margin of 7.00 lengths. Our Charlie Rose was Cleared.
