Acting under GAR 69(A)(1) stewards charged Fairytale Ending with failing to pursue the lure with due commitment. Mr Formosa pleaded guilty to the charge, Fairytale Ending was found guilty and suspended for 28 days at Ballarat and it was directed that</p>

the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Stewards spoke to Mr Alfred Barbara in regard to his failure to retrieve the greyhound Cosmic Fantasy in a timely manner, pursuant to GAR46. Stewards took into account Mr Barber's forthright evidence, guilty plea and good record in relation to this rule, and applied a fine of \$50.

Stewards spoke to Mr Thomas Boehmke in relation to presenting his greyhound for a satisfactory trial in a timely manner. Stewards accepted Mr Boehmke's explanation regarding the matter and reminded him of his obligation in relation to this matter for the future events.

MEETING COMMENTS

Satisfactory Trial Results - Nod Ya Head trialled over the 390m from box one, weight 32.2kg, the greyhound was placed second in a field of four. The time of the trial was 22.03, the greyhound was beaten by a margin of 6L. Nod Ya Head was cleared.

Satisfactory Weight Trial Results (not solo) - Carlanna Kervon trialled over the 390m from box four, weight 29.4kg, the greyhound was placed fourth in a field of four. The time of the trial was 22.03, the greyhound was beaten by a margin of 15.75L. Carlanna Kervon was cleared.
