Race 1

WARRNAMBOOL FENCING SPECIALISTS 5:32 pm 450m Mixed 6/7 Stewards spoke to Mr A.Setford, trainer of Maretto regarding the length of time the greyhound has had between races. Maretto last raced on 11 January 2018. Mr. Setford stated that the greyhound was resuming racing following split webbing to the right hind foot. Mr. Setford declared a new weight of 35.6kg for the greyhound in accordance with GAR 39(2). Maretto last raced at 34.4kg.

Maretto was slow to begin. Miracles Happen, Angel's Halo and Jemma's Fantasy collided soon after the start. Ledgerwood Molly and Lush Life collided approaching the first turn. Maretto, Lush Life and Smash Flash collided approaching the first turn, checking Lush Life, Miracles Happen, Angel's Halo and Jemma's Fantasy. Angel's Halo checked off Miracles Happen approaching the home turn. Maretto eased on the home turn and collided with Zoehanna Diva. Maretto checked off Lush Life in the home straight.

Maretto was vetted following the event. It was reported that there was no apparent injury found.

Stewards spoke to Mr. A. Setford, the trainer of the greyhound Maretto regarding the greyhounds racing manners on the home turn. Acting under GAR 69(A)(1) stewards charged Maretto with failing to pursue the lure with due commitment. Mr. Setford pleaded guilty to the charge, Maretto was found guilty and suspended for 28 days at Warrnambool and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Lektra Brandy collided approaching the home turn, checking Lektra Brandy. Don Quixote and St. Regis
collided approaching the home turn, and again entering the home straight.

Striking Bikini last raced on 4 January 2018. Mr Farley stated that the greyhound was resuming racing following a right hip injury.

A pre race sample was taken from Striking Bikini.

Last Princess was very slow to begin (4 Lengths). Xtreme Purpose and Lanis Morris collided soon after the start. Lektra Lucy and Lanis Morris collided approaching the first turn. Crymelon Kit, Lanis Morris and Striking Bikini collided on the first turn, checking Lanis Morris, Whiskey Rose, Lektra Lucy and Rubrica, and severely checking Crymelon Kit. Whiskey Rose checked off Lanis Morris on the first turn. Last Princess galloped on the heels of Lanis Morris on the first turn. Rubrica, Lanis Morris and Last Princess collided approaching the home turn, checking Whiskey Rose. Crymelon Kit and Whiskey Rose collided on the home turn.

Crymelon Kit was vetted following the event. It was reported that the greyhound sustained an injury to the left monkey muscle, a 10 day stand down period was imposed.

The numbers 8, 4, 6 & 7 inadvertantly appeared on the semaphore board before being corrected by the Judge to 8, 2, 4, & 6, the all clear was then given.

At Ballarat on Monday 2 April 2018, GRV Stewards inquired into an incident that occurred in the kennelling area at the Warrnambool Greyhound Racing Club on Thursday 8 February 2018, shortly after Race 2. After taking evidence from GRV Stewards Bettess, Rea, Watson and licensed Trainer Mr Greg Turnbull, the Stewards issued a charge to Mr Turnbull under GAR 86 (q). The specifics of the charge were that shortly after Race 2 on Thursday 8 February 2018, at the Warrnambool Greyhound Race Club Meeting held on that day, Mr Greg Turnbull, being a registered Trainer with GRV, engaged in conduct that was detrimental to the interests/image of greyhound racing by raising his voice and remonstrating aggressively in the kennelling area. Mr Turnbull pleaded guilty to the charge and was fined \$200. When determining penalty, stewards took into consideration Mr Turnbull's record, his guilty plea, his personnel antecedence and the forthright manner in which he conducted himself before the Stewards oday. Against these factors, stewards openly viewed by other industry participants and the message that uncivil behaviour such as this, is not acceptable from licensed persons and will not tolerated by GRV Officials.
