Race 1

TAB.COM.AU (300+RANK)

3:32 pm 400m Maiden Stewards spoke to Mr. P. Cusack, the representative of Gin Lee's Bullet regarding the length of time the greyhound has had between races. Gin Lee's Bullet last raced on 24 September 2017. Mr. Cusack stated that the greyhound had changed kennels.
