	SUPPLEMENTARY REPORT - THE MEADOWS 7 JULY 2018
	Stewards re-opened an inquiry from the Cranbourne meeting on July 4th 2018, regarding the reason

surrounding, Mr G. Carter allowing Why Not Leo to be removed from the kennels and left the track without having the greyhound vetted. Trainer Mr G. Carter gave evidence regarding the circumstances as to why the greyhound was not presented for a vet check and why he had left the course. Mr Carter added that when he returned home he noticed that he had missed calls and returned to the course immediately however the veterinarian had left the course. Stewards deliberated on the evidence given by Mr Carter and handed down a warning in this instance.

A veterinary examination of Why Not Leo was undertaken and no apparent injury was found.
