Satisfactory Trial Results (Turned in Boxes) - I'm Sorry trialled over the 400mtrs from box 1, weight 27.3kgs, the greyhound was placed 5th in a field of 5. The time of the trial was 23.07, the greyhound was beaten by a margin of 9 1/2 lengths. I'm Sorry was Cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr Keith Kelly, the trainer of Kynan's Revenge regarding the length of time since the greyhound last raced. Kynan's Revenge last raced on 10 January 2018 and returning from an extended spell. Pursuant to GAR 77A, Kynan's Revenge trialled over the 400mtrs from box 8, weight 34.5kgs, the greyhound was placed 3rd in a field of 5. The time of the trial was 23.07, the greyhound was beaten by a margin of 8 1/4 lengths. Kynan's Revenge was Cleared.
