Mitchell pleaded guilty to the charge, Dyna Hannah was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr D Fisher, the trainer of All Inn Fergi regarding the length of time since the greyhound last raced. All Inn Fergi last raced on 3/4/18. Mr Fisher stated that the greyhound was new to his kennel. Pursuant to GAR 77A, All Inn Fergi trialled over the 390m from box 3, weight 38.2kg, the greyhound was placed 1st in a field of 4. The time of the trial was 22.66, the greyhound won by a margin of 1.5L. All Inn Fergi was Cleared.
