Trial One:

Satisfactory Trial Results (GAR 77A) and Blinkers On- Stewards spoke to David Basile, the trainer of Rapana regarding the length of time since the greyhound last raced. Rapana last raced on 15 September, 2017. Mr D. Basile stated that the greyhound is resuming racing due to a spell Pursuant to GAR 77A, Rapana trialled over the 390m from box 1, weight 33.1kg, the greyhound was placed 2nd in a field of five starters. The time of the trial was 22.14, the greyhound was beaten by a margin of 10.25 lengths. Rapana was cleared with Blinkers.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to David Basile, the trainer of Soda Spike regarding the length of time since the greyhound last raced. Soda Spike last raced on 9 April, 2018. Mr D. Basile stated that the greyhound is resuming racing after a spell Pursuant to GAR 77A, Soda Spike trialled over the 390m from box 3, weight 30.5kg, the greyhound was placed 5th in a field of five starters. The time of the trial was 22.14, the greyhound was tailed off. Soda Spike was not cleared.

Soda Spike was vetted following the trial. It was reported that the greyhound sustained a laceration to the right hind paw, a 14 day stand down period was imposed.

Satisfactory Trial Results - La Vagabonde trialled over the 390m from box 5, weight 26.9, the greyhound was placed 1st in a field of five starters. The time of the trial was 22.14, the greyhound won by a margin of 10.25 lengths. La Vagabonde was cleared.

Auld stated that the greyhound is resuming racing after a left metacarpal injury Pursuant to GAR 77A, Dominant Lomar trialled over the 390m from box 2, weight 34.6kg, the greyhound was placed 1st in a field of five starters. The time of the trial was 22.38, the greyhound won by a margin of 3.5 lengths. Dominant Lomar was cleared.
