Trial One:-

390m Grade 5

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. S. Stefanos, the trainer of Winlock Bird regarding the length of time since the greyhound last raced. Winlock Bird last raced on 26th March 2018. Mr. Stefanos stated that the greyhound was resuming racing from a stomach muscle injury. Pursuant to GAR 77A, Winlock Bird trialled over the 390mt from box 1, weight 30.2kg, the greyhound was placed 3rd in a field of 4. The time of the trial was 22.50, the greyhound was beaten by a margin of 1.25L. Winlock Bird was cleared.

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. S. Stefanos, the trainer of Calleva regarding

the length of time since the greyhound last raced. Calleva last raced on 28th April 2018. Mr. Stefanos stated that the greyhound was resuming racing after being on season. Pursuant to GAR 77A, Winlock Bird trialled over the 390mt from box 3, weight 27.1kg, the greyhound was placed 4th in a field of 4. The time of the trial was 22.50, the greyhound was beaten by a margin of 5L. Calleva was cleared.
