Ms Fullerton pleaded guilty to the charge, Mr Frost was found guilty and Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Acting in accordance with GAR 71 (Cramp), Stewards directed that the greyhound must perform a Satisfactory Trial before any future nomination will be accepted.

Meeting Comments:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Melissa Fullerton, the trainer of Over The Radar, regarding the length of time since the greyhound last raced. Over The Radar last raced on 9 December 2017. Ms Fullerton stated that the greyhound was resuming racing following a left hamstring injury. Pursuant to GAR 77A, Over The Radar trialled over the 410m from box one, weight 32.4 kgs (amended 18/09), the greyhound was placed first in a field of four starters.. The time of the trial was 24:03, the

greyhound won by a margin of 1.75 lengths. Over The Radar was Cleared.
