Acting under GAR 69(A)(1) Stewards charged Adam Mandam with failing to pursue the lure with due commitment. Mr Crawford pleaded not guilty to the charge, Adam Mandam was found guilty and suspended for 28 days at Meadows and it was directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.
