Stefanos, the trainer of Supervisor regarding the length of time since the greyhound last raced. Supervisor last raced on 24th May 2017. Mr. Stefanos stated that the greyhound was resuming racing from having a back muscle injury. Pursuant to GAR 77A, Supervisor trialled over the 390mt from box 1, weight 31.2kg, the greyhound was placed 2nd in a field of 4. The time of the trial was 22.52, the greyhound was beaten by a margin of 3L. Supervisor was cleared.</p> <p>(GAR 77A) - Stewards spoke to Mr. S. Stefanos, the trainer of Berridale Buddie regarding the length of time since the greyhound last raced. Berridale Buddie last raced on 17th January 2018. Mr. Stefanos stated that</p>

the greyhound was resuming racing from having a triangle injury. Pursuant to GAR 77A, Berridale Buddie trialled over the 390mt from box 1, weight 36.0kg, the greyhound was placed 4th in a field of 4.
