Mrs Thompson pleaded guilty to the charge, Azkaban was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Dyna Wazza was vetted following the event. It was reported that the greyhound sustained a left hind spike wound, no stand down period was imposed.

Stewards spoke to Mrs L. Delbridge, the representative of Dyna Wazza regarding the greyhound's racing manners entering the back straight. Mrs Delbridge stated that Dyna Wazza's racing pattern is to shift wide at that part of the track and did so in a similar manner at the track two starts ago. Stewards viewed the replay from 6 September 2018 and noted the greyhound did shift out at the same point of the track, and raced wide towards the 720m boxes. Stewards accepted Mrs Delbridge explanation and as such took no action.

Stewards issued a warning to Mrs L. Delbridge, the representative of Dyna Wazza regarding the greyhound's racing manners on the home turn.
