Acting under GAR 69(B)(1), the stewards charged Zipping Sassy with failing to pursue the lure with due commitment (by reason of injury). Mr Rounds pleaded not guilty to the charge, Zipping Sassy was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1) (a), before any future nomination will be accepted.
