Acting under the provisions of GAR 69(A)(1) Rock Me Xanthe was charged with failing to pursue the lure with due commitment. Mr. Dann pleaded not guilty to the charge, Rock Me Xanthe was found guilty and suspended for 28 days at Cranbourne and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(a) before any future nomination will be accepted.

Urana Hope underwent a post-race veterinary examination - no apprent injury was reported.

Stewards spoke to Mr Simon Mallia, the Trainer of Urana Hope regarding its performance in this event. Stewards deemed the performance unsatisfactory, acting in accordance with GAR 71, Urana Hope must perform a Satisfactory Trial (all tracks) before any future nomination will be accepted.

Big Unit underwent a post-race veterinary examination and was found to have a left wrist injury. A 10 day stand down period was imposed.
