Jye Licious underwent a post-race veterinary examination and was found to have a right elbow injury and a spike wound to the right stopper. A 21 day stand down period was imposed. Stewards spoke to Mr. Jye Formosa, regarding the greyhounds racing manners on the home turn. Acting under the provisions of GAR 69(B)(1), Jye Licious was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Formosa pleaded guilty to the charge, Jye Licious must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

Bad Ones – Performed a Stewards Satisfactory Trial as the greyhound was stood down from racing at Ballarat for marring. Weighing 29.0kg and beginning from box 1, Bad Ones completed the 390mts trial distance in a time of 23.21. Bad Ones placed 4th in a field of 4 beaten by 15.75L. Bad Ones has been cleared to race at all tracks except Ballarat.

Fabelite – Performed a Stewards Satisfactory Trial as connections wish to apply blinkers to the greyhound. Weighing 37.0kg and beginning from box 3, Fabelite completed the 390mts trial distance in a time of 22.57. Fabelite placed 2nd in a field of 4 beaten by 6.5L. Fabelite has been cleared to race in blinkers.

Cabin Fever – Performed a Stewards Satisfactory Trial as connections wish to apply blinkers to the greyhound. Weighing 34.7kg and beginning from box 8, Cabin Fever completed the 390mts trial distance in a time of 22.12. Cabin Fever placed 1st in a field of 4 winning by 6.5L. Cabin Fever has been cleared to race in blinkers.
