MEETING COMMENTS:

Satisfactory Trial Results (GAR 77A) - Stewards spoke to Mr. M. Clarke, the trainer of Pancake regarding the length of time since the greyhound last raced. Pancake last raced on 23rd March 2018. Mr. Clarke stated that the greyhound was returning to racing after a right back muscle injury. Pursuant to GAR 77A Pancake trialled over the 395m from box 1, weight 27.0kgs, the greyhound was placed 1st in a field of 4.

The time of the trial was 22.80, the greyhound won by a margin of 3.50 lengths. Pancake was Cleared.
