Pursuant to GAR 77A, Nitro Nicole trialled over the 390m from box 1, weight 30.0 kg, the greyhound was placed 2nd in a field of 4 starters. The time of the trial was 22.90, the greyhound was beaten by a margin of 3L. Nitro Nicole was cleared.</p> <p>Satisfactory Trial Results (stayed in the boxes) - Golden Moon trialled over the 390m from box 2, weight 27.5kg, the greyhound was placed 4th in a field of 4 starters. **Trial Two:**
