Satisfactory Trial Results - Tahbilk trialled over the 440m from box 8, weight 35.2kgs, the greyhound was placed 1st in a field of 4. The time of the trial was 25.53, the greyhound won by a margin of 1.50 lengths. Tahbilk was Cleared.

Satisfactory Trial Results - Pocket Dial trialled over the 440m from box 6, weight 32.6kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 25.53, the greyhound was beaten by a margin of 1.50 lengths. Pocket Dial was Cleared.

Satisfactory Trial Results - Hurricane Dylan trialled over the 440m from box 1, weight 31.2kgs, the greyhound was placed 4th in a field of 4. The time of the trial was 25.53, the greyhound was beaten by a margin of 12.75 lengths. Hurricane Dylan was Cleared. Hurricane Dylan was checked on the home turn.
