Meeting Comments:

Satisfactory Trial Results (GAR 77A) -

Stewards spoke to Mr. G. Taylor, the trainer of Talanjee Chief regarding the length of time since the greyhound last raced. Talanjee Chief last raced on 3 July 18. Mr Taylor stated that the greyhound was returning to racing following a toe injury. Pursuant to GAR 77A, Talanjee Chief trialled over the 450m from box 5, weight 28.0kgs, the greyhound was placed 2nd in a field of 4. The time of the trial was 25.44 the greyhound beaten by a margin of 4.5L. Talanjee Chief was cleared.

Satisfactory Trial Results -

Kinmoss Brave trialled over the 450m from box 8, weight 33.7kgs the greyhound was placed 1st in a field of 4. The time of the trial was 25.44, the greyhound won by a margin of 4.5L. Kinmoss Brave was cleared.
