Acting under GAR 69(B)(1), the stewards charged Sale Graze Bindi with failing to pursue the lure with due commitment (by reason of injury). Miss Toner pleaded not guilty to the charge, Sale Graze Bindi was found guilty. Stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.</p>
