A 21 stand down period was imposed. Stewards spoke to representative, Mr C Schlenso, regarding the greyhounds racing manners in the back straight. Acting under the provisions of GAR 69(B)(1), Come On Pepper was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Schlenso pleaded guilty to the charge, Come On Pepper must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.</p>

Weighing 29.2kgs and beginning from box 3, Start A Riot completed the 525m trial distance in a time of 30.12. Start A Riot placed second in a field of four beaten by .5L. Start A Riot has been cleared to race at all tracks.
