The following Greyhounds performed a Stewards Satisfactory Trial – The trail took place over 390m with five greyhounds required to trial. The winning time of trial was 22.24:

Tat Tubby – Was stood down from racing at Bendigo for unsatisfactory behaviour in the catching pen. Weighing 31.7kg and beginning from box 1 beaten by 4.25L. Tat Tubby has been cleared to race all tracks.

Aunty Chris – Was stood down from racing at Bendigo for failing to pursue the lure. Weighing 26.0kg and beginning from box 2 beaten by 10.75 L. Aunty Chris has been cleared to race all tracks except Healsville.

Whiskey Rose – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a metatarsal injury. Weighing 26.3kg and beginning from box 3 beaten by 8.75L. Whiskey Rose has been cleared to race.

Tiny Wally – Was stood down from racing at Bendigo for failing to pursue the lure. Weighing 34.7kg and beginning from box 4 beaten by 15.75L. Tiny Wally has been cleared to race all tracks except Bendigo.

Tat Toby – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a monkey and back muscle injuries. Weighing 33.8kg and beginning from box 5 beaten by 19.25L. Tat Toby has not been cleared to race after sustaining a injury to the left thigh.A 28 day stand down period was imposed.

Pride Of Oasis – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months spell. Weighing 36.6kg and beginning from box 6 winning by 4.25L. Pride Of Oasis has been cleared to race.
