Bring The Spring checked off Ringcraft at the 250m mark. Ringcraft and What's His Caper collided at the 200m mark. Friend In Me and Fabulous Dan collided at the 100m mark. Friend In Me and Jack Skywalker collided at the 50m mark.</p> <p>Meeting Comments:</p> <p>The following Greyhounds performed a Stewards Satisfactory Trial – The trial took place over the 350m with 5 required to trial. The winning time of the trial was 19.81:</p> <p>Totally Bullish – Performed a satisfactory trial as connections wish to return the greyhound to racing from retirement. Totally Bullish trialled from box 2, weighing 34.4kg. Totally Bullish completed the trial in a time of 19.81 and was placed first winning by 2L. Totally Bullish has been cleared to race.</p> <p>Boney Power – Performed a satisfactory trial as the greyhound has not competed in an event for in excess of six months after being on season. Weighing 28.4kg and beginning from box 1, Boney Power completed the trial in a time of 19.96 and was placed second beaten by 2L. Boney Power has been cleared to race.</p>

Tommy Boy – Performed a satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a right thigh injury and change of kennel. Weighing 31.1kg and beginning from box 5, Tommy Boy completed the trial in a time of 21.11 and was placed fifth beaten by 18.25L. Tommy Boy has been not cleared to race.
