In considering the penalty, Stewards took into consideration Mr Galea's guilty plea and his

previous breach of this rule within the last 12 months.

Meeting Comments

Federal Impact – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Sandown for marring. Weighing 31.2kg and beginning from box 1, Federal Impact completed the 515m trial distance in a time of 29.51. Federal Impact placed 1st in a field of 4 starters winning by 15.75 lengths. Federal Impact has been cleared to race at all tracks. Federal Impact – Not raced for in excess of 3 months and is returning to racing from left hock injury.

Ronray Legend – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Gawler for marring. Weighing 34.9kg and beginning from box 2, Ronray Legend completed the 515m trial distance in a time of 30.61. Ronray Legend placed 2nd in a field of 4 starters beaten by 15.75 lengths. Ronray Legend has been cleared to race at all tracks except Gawler.

Dyna Quail – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at Sandown for marring. The connections wish to apply blinkers to the greyhound Weighing 22.7kg and beginning from box 8, Dyna Quail completed the 515m trial distance in a time of 30.69. Dyna Quail placed

4th in a field of 4 starters beaten by 16.75 lengths. Dyna Quail has been cleared to race at all tracks in blinkers.
