Due to Mr James' absence, there was no plea entered in relation to the charge. Sure To Excite was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.

An inquiry into the reason for Mr James leaving course without permission will be convened at a time and date to be fixed.
