The winning time of trial was 22.62:</p> <p>Aston Zoro – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to left stopper tendon injury. Weighing 30.8kg and beginning from box 3, Aston Zoro completed the trial in a time of 22.62. Aston Zoro placed 1st in a field of 4 winning by 4.5L. Aston Zoro has been cleared.</p> <p>Gazza's Pick – Was stood down from racing at Shepparton for turning in the boxes. Weighing 33.9kg and beginning from box 8, placed fourth in a field of four, beaten by 5.5L. Gazza's Pick has been cleared.</p>
