A pre-race sample was taken from Hammer Head.

Acting under the provisions of GAR 69(B)(1), Bomber's Return was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. G.Green Trainer pleaded guilty to the charge, Bomber's return must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted
