Gladiator checked off Zoe's Intention entering the back straight. Smokey Renn raced wide in the home straight.

Smarty Pants underwent a post-race veterinary examination and was found to have a left stopper pad, right sesamoid and left back muscles injuries, abrasions to the left fore foot and stopper and a spike wounds to the scrotum and left hind foot. A 10 day stand down period was imposed.

Mister Harlewood and Fernando Porche collided on the second turn checking Fernando Porche. Figure Eight and Valencia Kid collided entering the back straight checking Figure Eight. Valencia Kid checked off Fernando Porche approaching the third turn. Fernando Porche and Waging War collided on the third turn. Valencia Kid marred Waging War on the home turn.

Valencia Kid underwent a post-race veterinary examination and was found to have a right deltoid injury. A 7 day stand down period was imposed.

Stewards spoke to Mrs J. Gieschen, the trainer of Valencia Kid regarding the greyhounds racing manners on the home turn. Acting under the provisions of GAR 69(1) Valencia Kid was charged with marring. Mrs Gieschen pleaded not guilty to the charge, Valencia Kid was found guilty and suspended for 28 days at Sandown and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(a) before any future nomination will be accepted.
