Acting under the provisions of GAR 69(A)(1) Brakae was charged with failing to pursue the lure with due commitment. Mr Willcocks pleaded not guilty to the charge, Brakae was found guilty and suspended for 3 months at all tracks and must perform a Satisfactory Trial (all tracks), pursuant to GAR 69(A)(2)(b) before any future nomination will be accepted.

For The Horde underwent a post-race veterinary examination and was found to have sustained injuries to the right sartorius muscle and right deltoid muscle. A 10 day stand down period was imposed. Stewards spoke to trainer, Mr Matthew Lanigan regarding the greyhounds racing manners approaching the second turn. Acting under the provisions of GAR 69(B)(1), For The Horde was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Lanigan pleaded not guilty to the charge, For The Horde was found guilty and must perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a) before any future nomination will be accepted.
