Weighing 33.5 kgs and beginning from box one, Mr Worldwide completed the 410m trial distance in a time of 23:70. Mr Worldwide placed second in a field of four beaten by four lengths. Mr Worldwide has been cleared to race.

Ranga – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at the Ballarat for marring. Weighing 36.6 kgs and beginning from box eight, Ranga completed the 410m trial distance in a time of 23:70. Ranga placed first in a field of four, winning by four lengths. Ranga has been cleared to race at all tracks except (Ballarat).

Stewards spoke to Trainer Mr G. Gledhill regarding his non-compliance with GRV's Transportation Policy. Mr Gledhill stated that he was unaware that today's meeting was deemed 'Heat Affected' until he was already en-route to the track. Stewards accepted Mr Gledhill's explanation.
