Meeting Comments:

Distributor – Performed a Stewards Satisfactory trial as the greyhound has not competed in an event for in excess of six months due to a right foreleg injury. Weighing 32.7kg and beginning from box 1, Distributor completed the 425m trial distance in a time of 24.91. Distributor placed 2nd in a field of 4 beaten by 1 length. Distributor has been cleared to race.

Kraken Jane Babe – Performed a Stewards Satisfactory trial as the greyhound was stood down from racing at the Bendigo track for marring. Weighing 27.1kg and beginning from box 8, Kraken Jane Babe completed the 425m trial distance in a time of 24.91. Kraken Jane Babe placed 4th in a field of 4 beaten by 2 lengths. Kraken Jane Babe has been cleared to race at all tracks.
